#### Pro Per

A trailblazing legal program that provides very low-income persons with high levels of self-help assistance, empowering them to make decisions and represent themselves in court.

#### Pro Bono Panel

Utilizing the donated services of private attorneys, the Center imparts free legal representation to poor individuals who cannot represent themselves in court due to severe abuse, disability or other circumstances.

#### **Domestic Violence Project**

Intensive, ongoing assistance provided to victims of abuse, helping them to secure orders for protection and assistance, and to shield their children from harm, thereby building the foundation for stable and successful futures.

### Community College and Neighborhood Outreach Program

On-site legal counseling sessions and educational presentations for low-income students who are experiencing intimate family challenges to give them the support they need to stay in school.

#### Family Reunification and Reentry

Designed by the Center to reduce recidivism and facilitate healthy family reunification, this program aids incarcerated mothers in domestic violence and child custody matters upon reentry.

#### Fatherhood Project

Legal education workshops on child support, custody, visitation, child welfare, and paternity help low-income dads become more active and responsible participants in the lives of their children.

#### Women Veterans Project

Aimed at helping this oft-overlooked group, the project addresses domestic abuse of women veterans, educating them and their service providers about recognizing intimate partner violence and how and where they can get help.

#### Volunteer and Law Student Development

Combining a program of volunteer management with training and education, the Center is the vehicle by which over 300 lawyers, law students, and others give back to the community thousands of hours of donated time each year.

#### and also helped the Harriett Buhai Center:

- Reduce expenses by 59%;
- Provide free legal help to 906 very low-income individuals and families, including 1,140 children;
- Generate nearly 15,000 hours of free legal services donated by volunteer attorneys, paralegals, and law students that was matched by over 12,000 hours of work produced by staff attorneys and paralegals.
