The **Century Campaign** is one way to ensure the continuation of Harriett Buhai Center for Family Law services and programs for generations to come.

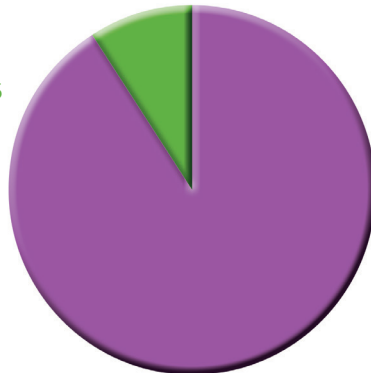
